Legislative Update from the State House

With Election Day over, legislators returned to the State House in November and Committee meetings were back in session. On the 16th, The Arc of New Jersey Family Institute and a group of families traveled to the capital and spoke to more than 35 legislators about the challenges associated with caring for a loved one with intellectual and



developmental disabilities. The event, a part of our Family Caregivers Awareness Month celebration, gave families an opportunity to speak with elected officials about a number of issues such as the importance of respite, the length of the Waiting List, and the need for housing. In addition, our family representatives were honored and presented with a resolution at the start of the Assembly Human Services Committee by Chairwoman Valerie Huttle and members of her Committee. Medicaid provides cost-effective coverage for low-income individuals. In New Jersey, Medicaid eligibility is now required in order to receive Division of Developmental Disabilities (DDD) funded services. This important reform ensures the state's ability to maximize the receipt of federal revenue, and to preserve and enhance community-based supports for individuals with intellectual and developmental disabilities. Individuals who are new to the Division are required to meet the functional criteria and have Medicaid eligibility before they can begin receiving a service. This webinar will inform you of the different ways to initiate the eligibility process, information needed to complete the process, and updates on federal and state regulations.
