

The Arc of NJ Takes Advocacy to Capitol Hill

Representatives from The Arc of New Jersey, local County Chapters, families and self-advocates attended the annual Disability Policy Seminar in Washington, DC last month and pushed back against potential threats to Medicaid while meeting with 10 members of New Jersey's Congressional delegation or their staff.

These meetings were an opportunity to voice our strong disapproval of block grants and per capita caps - two proposals being discussed by lawmakers. In partnership with the New Jersey Council on Developmental Disabilities, advocates strongly opposed these



policy proposals and explained to lawmakers about the devastating effects these changes would have on people with intellectual and developmental disabilities and their families. We are happy to report that at the end of March, Speaker Paul Ryan announced that the House of Representatives would not bevoting on the American Health Care Act. This was a big advocacy win and wethank everyone who participated in action alerts and weighed in with their representatives. We will continue to monitor any future threats to Medicaid andwill keep you informed as news develops. More information about the "Protect the Lifeline" campaign can be found here.

Self-Advocates and Family Members Testify at Budget Hearings

In addition to our advocacy in Washington, DC, The Arc of New Jersey continued to push forward with our State Budget campaign. As Chair of the Coalition for a DSP Living Wage, we are working to increase wages for Direct Support Professionals in the FY18 Budget. Executive Director Tom Baffuto and Board President Bob Hage testified before the Assembly Budget Committee and Self-Advocate Evelyn Ramundo testified before the Senate Budget Committee last month. The Arc of New Jersey continues to urge our State legislatures to address this important issue and recognize the critical work of our Direct Support Professionals. The theme of this year's event and design contest was "Developmental Disabilities Awareness: It Matters to Me."  Differentiating Problematic Sexual Behavior Related to Autism Spectrum Disorders (ASD) vs Paraphilic Disorders: Pt 2 ADULTS.

Thursday, April 6 at 1 pm

During this hour-long webinar our speakers, Dr. Kim Spence and Dr. Eric Imhof, will begin a brief overview of literature regarding autism spectrum disorders (ASD) and problematic sexual behavior. Here the presenters will elucidate clinical



differences in adult clients with ASD who engage in inappropriate sexual behavior versus clients with ASD and co-morbid deviant sexual interests. During this webinar, we will discuss best practices for assessment including differential diagnosis, risk assessment, identification of client needs, and how to respond with comprehensive multi-disciplinary treatment planning will be discussed utilizing a number of case examples.
