In December, The Arc of New Jersey supported a number of bills making their way through the legislative process. It is important to note that any legislation not signed into law by January 11, 2016 will expire. That means that any pending bills will have to be reintroduced in the new legislative session, in both houses, and moved again through Committees and voting sessions.
