## The Arc of NJ Voices Support on Legislation

During the month of December, The Arc of New Jersey testified at the State House in support of multiple bills impacting people with intellectual and developmental disabilities. Our organization supported legislation that would expand the background check procedure for staff employed by community providers. Our Executive Director Tom Baffuto spoke in favor of the bill when it went through the Assembly Human Services and Senate Budget Committees and it has since passed by the full Senate. In addition, The Arc of New Jersey supported legislation that would decrease the use of restraint techniques on students with disabilities. The bill was approved by the Assembly Health Committee and now awaits further action. Also in December, we supported a bill that would eliminate certain motor vehicle fees for non-profit organizations providing services to individuals with I/DD. To continue reading, click here.

#### Webinar: Early Intervention and Preschool Services Tuesday, January 9 at 6 pm

An Early Intervention evaluation may be the first step to find out about a child's developmental strengths and needs - whether the child is losing previously acquired skills or just does not seem to be progressing in his/her development. Hosted by The Arc of New Jersey Family Institute and presented by Hinkle, Fingles, Prior & Fischer, Attorneys at Law, attendees will learn eligibility requirements, what children and their families are entitled to and how to prepare for transition from Early Intervention services.



## Webinar: Equal Justice Talks: Counterfeit Deviance: What is it and What Does the Research Tell Us?
