## Legislators, Administration Recognize Self-Advocates

Approximately 20 Self-Advocates from the New Jersey Statewide Self-Advocacy Network traveled to Trenton in March to promote and celebrate Developmental Disabilities Awareness month at the State House. This annual event gave Self-Advocates the opportunity to speak with more than 50 elected officials, including the Senate President, the Speaker of the Assembly, the Senate and Assembly Majority Leaders as well as Budget Committee members and other important decision-makers. In addition to the important conversations with our state representatives, the Self-

Advocates were also honored with a joint legislative resolution from Senate Majority Leader Weinberg and Assemblywoman Huttle who chairs the Assembly Human Services Committee. Furthermore, Department of Human Services Commissioner Beth Connolly came down to the State House and presented the Self-Advocates with a proclamation from the Governor declaring March 2016 as Developmental Disabilities Awareness Month in New

# CJAP Dir. Talks Employment Barriers for People with Both I/DD & Criminal Histories

Jessica Oppenheim, The Arc of New Jersey's Director of the Criminal Justice Advocacy Program (CJAP), recently presented a workshop entitled: "Job Development for People with Developmental Disabilities Who Have Criminal Histories." The workshop, which was done in partnership with Katelynne Collick, Coordinator, Employment and Transition Services at the Division of Developmental Disabilities, took place at the Facing the Future 24: Discovering a World of Employment Opportunities Conference in New Brunswick. As New Jersey strives to be an Employment First

State for all people with intellectual and developmental disabilities, it becomes imperative to talk about this issue and assist supported employment specialists with the difficult task of securing and keeping jobs in the community.

More than 90% of employers now conduct a background check and across the country 1 in 40 adults has a criminal record. In addition, people with I/DD are grossly overrepresented in the criminal justice system. Having a developmental disability can add more obstacles for a person with a criminal history. Offenders with I/DD often plead guilty to more serious charges, spend more time in prison and are unable to take advantage of programs while incarcerated that can improve the likelihood employment. The workshop presentation was a great of findina opportunity to arm supported employment professionals with updated information about expungement, Megan's Law, background checks, and other issues that impede employment success. Professionals received practical tips about identifying employers, making it through the application process and keeping jobs in the long term. Providers also took away pamphlets for clients, explaining the criminal justice system and how to interact with law enforcement.

### Free Tax Return Help

In IR-2016-35, the IRS reminded taxpayers that there is free tax help available. First, the Volunteer Income Tax Assistance (VITA) program is available for persons with incomes of \$54,000 or less, disabilities or limited English proficiency. Second, Tax Counseling for the Elderly (TCE) is available for persons age 60 and older.



A key area of interest for both VITA and TCE is the Earned Income Tax Credit (EITC) and the child and dependent care credit. The EITC is refundable for qualifying taxpayers who have earned income. Last year, nearly \$66.7 billion

was refunded under this program. The amount per recipient was about \$2,400. The maximum benefit for year 2015 is \$6,242. You must file IRS Form 1040 to receive the EITC benefit.

For additional information on VITA or TCE, go to www.irs.gov and download Publication 3676-B. There is also a "locator" tool on irs.gov and the smartphone app "IRS2GO". The locator tool will help you find the nearest location with a VITA or TCE program.

If you want to make use of VITA or TCE, you will need to take several items to the location.

1. **Identification** - You will need a photo ID. This is usually a driver's license or similar document.

2. **Social Security Card** - Bring the Social Security cards of the taxpayer, spouse and all dependents. The birthdates of everyone must also be available.

3. Income Tax Identification Number (ITIN) - An ITIN may be an acceptable substitute for a Social Security Number.

4. Wages and Earnings - You will need your W-2s, Forms 1099-R or Forms 1099-MISC.

5. **Banks and Credit Unions** - Gather all of your income and dividend statements. If you have a mortgage and plan to itemize deductions, you will need that statement from your lender.

# Use Your IRA to help The Arc

With tax season in full swing, most of us have taxes on our mind. If you owe income taxes for 2015, it is now too late to change that situation. However, this can be a great time to consider how you can reduce your 2016 tax liability while providing much needed support to The Arc of New Jersey now.

There are several ways you can help us:

- 1. Make a donation at <u>www.arcnj.org</u>.
- 2. If your company has a matching gift program, be sure to register your gift so you can double your contribution.
- Make your donation count all year long by becoming a monthly Sustainer. All you have to do is note on your online donation that you would like it to be a monthly contribution.
- 4. Donate a vehicle by calling (877) 272-2270.
- Shop through Amazon Smile. Simply select The Arc of New Jersey from the charities at <u>Amazon Smile</u>, and shop like you always do at Amazon.

If you are age 70 ½ or older and own a traditional IRA, you will need to take a required minimum distribution (RMD) from it. This is mandated by the federal government. In fact, the government imposes a significant penalty on those who do not take their RMD. If you find yourself in this position and are already planning to make a gift to The Arc of New Jersey in 2016, you could make a gift of some or all of your RMD.

Did you know that by making your gift using an IRA charitable rollover (a direct transfer from your account to The Arc) you will not pay income taxes on that amount which is given as a gift? Since there is no tax deduction available on the transfer, this type of gift can work well even for those who do not itemize their taxes.
