The Arc Testifies on FY20 Budget Priorities

Last month, The Arc of New Jersey testified at the Department of Human Services (DHS) Budget Listening Session about funding priorities for people with intellectual and developmental disabilities (I/DD) and their families. Held on December 5, the Listening Session was an opportunity to communicate with DHS Commissioner Johnson and senior members of her team about the Fiscal Year 2020 State Budget. As a member of the Coalition for a DSP Living Wage, The Arc of New Jersey focused our testimony on the ongoing Direct Support Professional workforce crisis. In addition, Executive Director Tom Baffuto spoke about the need to review and adjust the day program rate and he advocated for one-time capital funding to pay for costs that will no longer be covered in the fee-for-service system. New Jersey, and the Northward Center for Autism and was the Vice President of Adult Services at Autism Speaks.
