NEW JERSEY COUNCIL ON DEVELOPMENTAL DISABILITIES (NJCDD)

State Councils on Developmental Disabilities (Councils) are federally funded, self-governing organizations charged with identifying the most pressing needs of people with developmental disabilities in their state or territory. Councils are committed to advancing public policy and systems change that help these individuals gain more control over their lives.

The 56 Councils across the United States and its territories work to address identified needs by conducting advocacy, systems change, and capacity building efforts that promote self-determination, integration, and inclusion. Key activities include conducting outreach, providing training and technical assistance, removing barriers, developing coalitions, encouraging citizen participation, and keeping policymakers informed about disability issues.

PROGRESSIVE CENTER FOR INDEPENDENT LIVING (PCIL)

PCIL is a private, not-for-profit organization that works with people with all disabilities to advance their independence. PCIL provides services that promote leadership, empowerment, independence, and productivity of people with disabilities. We work within communities to remove barriers and change attitudes towards independence. Fifty One percent or greater of the people serve on our Board of Directors as well as the majority of staff are people with disabilities.

PCIL serves people in Mercer, Hunterdon, and Somerset Counties. There are 12 CILs in NJ.



Limits to Supported Employment

Supported Employment does NOT:

1-1 for long term

Safety Monitoring

Task Prompting

Social Interaction

Completion of job tasks

*Intensive assistance from DVRS ends roughly 90 days from outset

*DDD budget handles long term coaching needs

Benefits Counseling & Workability


Benefits Counseling – 1:1 conversation with a Certified Benefits Counselor to learn what the financial impact of working will have on your Social security benefits. Paid for by DVR and DDD.

<u>Workability</u> – Type of Medicaid that allows you to make a livable wage and maintain your Medicaid benefits.

A single individual's gross earned income may not exceed \$73,932 per year or \$6,161 per month.










Working is your CHOICE
