# Proposed FY21 Budget Maintains Funding for Supports & Services, Raises DSP Wages

The Arc of New Jersey is very excited and pleased to report that the Governor's proposed FY21 Budget does not include cuts to Department of Human Services funded services and supports for people with intellectual and developmental disabilities and their families. In addition, the Budget proposal does include funding to raise wages for Direct Support Professionals (DSP). In light of the devastating impact of COVID-19 on the state's revenues, this is an absolutely tremendous victory and a deserved recognition of the DSP workforce and the assistance they provide to people with intellectual and developmental disabilities both before the pandemic and throughout the past 6 months. The Legislature is now reviewing the Governor's proposed Budget. Legislators will determine what if any changes they want to make to the funding plan and then must send it back to the Governor by September 30, 2020. Please participate in our action alert to weigh-in with lawmakers ahead of that deadline. It is critical that all funding proposals outlined in the Governor's Budget for people with intellectual and


### **Executive Director Interviewed by Steve Adubato**

Election Day is Tuesday, November 3, 2020, but due to COVID-19, this year's voting process will look very different than it has in the past. All active registered voters will automatically receive mail-in ballots for voting in the 2020 General Election without the need to submit a vote by mail application. ## **US Senators Must Support People with I/DD**

People with disabilities and those who support them can't be left behind! The critical needs of people with disabilities, their families, and the direct support professional (DSP) workforce must be included in the next coronavirus relief bill. The U.S. House of Representatives passed legislation that includes many of our top asks – but the Senate introduced a bill that does NOT address most of the critical needs of people with disabilities! Your Senators need to hear from you so that these and other important provisions remain in the bill that ultimately passes Congress:



- Dedicated funding for Medicaid home and community-based services (HCBS).
- Personal protective equipment (PPE) for direct support professionals.
- Paid leave for all caregivers.
- Economic impact payments for all people with disabilities.

# Planning for Adult Life Will Offer Virtual MAPs Classes for High School Students

With so much uncertainty surrounding the 2020-2021 school year, we know children receiving special education services and their parents are concerned about how COVID will impact learning as well as progress toward graduation and next steps. With this in mind, The Arc of New Jersey's Planning for Adult Life (PFAL) Program will now offer virtual Making Action Plans (MAPs) classes for any high school student receiving special education services in New Jersey. These online classes will focus on, among other things, making decisions, problem solving, how to set priorities, managing disappointment and failure, dealing with



uncomfortable situations, and how to ask for help. Using different techniques, students will practice skillbuilding and stay engaged by interacting with peers and PFAL Transition Navigators. We know COVID-19 will change the way schools operate in the fall, but your child's planning for adult life does not need to take a back seat because of it. The MAPs classes are available to any student, regardless of whether the student's school district is connected to the PFAL program. # Webinar: Using Legislative Options to Reform Laws to Assist People with I/DD Who Are Caught Up in the Criminal Justice System

#### Thursday, September 17 at 2 pm

Join us for the first Equal Justice Talks webinar to hear how families are working to improve the criminal justice system for people with IDD. LRIDD is a parent support and advocacy group which began as a grassroots parent advocacy group and has grown into a national movement of families and professionals seeking criminal justice reform for individuals with IDD who have become involved in the criminal justice system. As we know, people with IDD are grossly overrepresented in the criminal justice system, though their disability is overlooked in investigation, prosecution and sentencing. The speakers will discuss the creation of the movement, particularly the activities and successes around changing legislation and provide suggestions for further criminal justice reform. Our speakers will also share their personal struggles on behalf of their family member and themselves, describing how arrest, prosecution, incarceration and re-entry has had a devastating impact on individuals with IDD and their families. LRIDD and The Arc of Virginia have gained recognition for their work on these legislative reform issues and they will offer a blueprint for working successfully toward change.
