

Chapter Spotlight: The Arc Somerset Exec Retiring After More Than 30 Years Supporting People with IDD

Lauren Frary, Executive Director at The Arc of Somerset County, is retiring after more than 30 years with the organization. We celebrate Lauren's commitment and dedication to people with intellectual and developmental disabilities and we wanted to use this space to hear more about her journey in The Arc family.

1. How many years have you worked at The Arc of Somerset County and what originally attracted you to this field?

As a graduate student at Montclair University, I was studying to become a Licensed Clinician, hoping to work as a School Guidance Counselor. During my studies, I needed to work to pay for tuition and books and so I applied for and was



offered a job as a Behavioral Support "technician" at the now closed North Jersey Developmental Center. As you can imagine, this was an eye opening experience an one that completely changed the course of my life. I immediately understood the urgency to advocate for individuals with disabilities and to promote community services. During this time, I was introduced to The Arc of Somerset County by a friend and was invited to join the Arc team after I finished my degree. Direct care workers are underpaid, which leads to high turnover, critical staffing shortages, and compromised care for many people with disabilities.
