- The New Jersey Department of Health (DOH) issued a policy
 permitting support persons to stay with hospitalized patients with
 intellectual and developmental disabilities (I/DD) on April 25, and then an updated policy on May

- The New Jersey Department of Human Services (DHS) hosted a Facebook Live event last month to answer questions related to COVID-19. To view a recording of that event, click here.
- DHS updated their <u>Quick Guide for Families</u> which now provides "condensed, easy-to-understand information from the policy manuals for both of the Division of Developmental Disabilities' Medicaid waiver programs, the Supports Program and the Community Care Program."
- Governor Murphy released a "Standing Order" for testing in May. According to the Department of Human Services, this standing order is "essentially a universal prescription for a COVID-19 test so one is not needed from a doctor." It also "means that direct support professionals who work in group homes and the individuals they serve do not need to have symptoms or a prescription to be tested for COVID-19. It also means that individuals who reside at home with their families can be tested if they meet any of the criteria." To read the <u>Standing Order, click here</u>.

New Video Explains COVID-19 Test, What to Expect

 In an effort to reduce the spread of the Coronavirus, the Division of Developmental Disabilities is encouraging everyone with I/DD who receives services from the Division to be tested for COVID-19.



In this time of technology, it is critically important that we explore all the mediums at our disposal in our mission to educate and advocate for individuals with developmental disabilities (I/DD) and their families. It is our goal to help individuals with I/DD navigate this confusing and challenging time. Toward that end, we created this short video on the COVID-19 nasal swab test to better prepare individuals who may need to take the test, to set appropriate expectations of the experience and to remove fear and unnecessary worry about the process. Medical professionals have explained that although some people who are positive for COVID-19 have symptoms (including a high fever and a cough), others who have this virus are asymptomatic and do not have any symptoms at all.
