For dose to a year, the NJ Self-Advocacy Project has been interviewing people with I/DD, asking them how transportation in NJ affects their lives. The Transportation Research Project focused on the significant impact transportation - or lack of - has on the lives of people with I/DD. With more than 120 interviews posted, and more to come, the message is

very clear that NJ's limited public transportation system is an enormous barrier to people with I/DD living included lives in the community. The interviews and resulting podcast, titled "In Their Own Words" is supported by a grant from the NJ Council on Developmental Disabilities.

If you or your loved ones receive benefits from Social Security, you have a legal obligation to report changes, which could affect eligibility for SSI benefits and Medicaid. Hosted by The Arc of New Jersey Family Institute and presented by David Vinokurov, District Manager for the New Jersey Social Security Administration Office in Trenton, attendees will learn how to report changes for your SSI benefits and avoiding SSI overpayments and underpayments.
