Competitive Employment - What is it?

Competitive Employment is work that is performed on either a full- or part-time basis in which individuals are compensated for their work in an integrated setting. The compensation paid must be at or above the set minimum wage, but not less than the wages paid to individuals who are not disabled who perform the same or similar work.

There are other types of employment such as sheltered or enclave but individuals working in these arrangements are not able to access the same services as those who work competitively.

Benefits of working competitively

- Self determination and choice in employment
- Independence through earning of own income
- Increased self worth and higher self esteem
- Opportunities gained from being in the community

- Potential to earn more than SSD/SSDI benefit checks alone can provide while maintaining Medicaid
- Learn new skills, both technical and social
- Potential for personal growth when leaving "comfort zone"
- Gained sense of belonging and being a part of something larger than one's self

Essentially, an improved...



New Jersey is an "Employment First" State

This initiative:

- Presumes that people with disabilities can, and should work
- Creates the expectation the people with disabilities, like everyone else, will need to "opt out" of employment rather than "opt in"
- Guides policy and resources related to the employment of persons who live with disabilities
- Helps to define the primary service that individuals living with disabilities utilize when obtaining and maintaining competitive employment - Supported Employment

Supported Employment - What is it?

While it differs slightly between funding sources, Supported Employment assists individuals in obtaining competitive employment in an integrated setting, or employment in which individuals are working toward competitive employment, consistent with the skills, interests and preferences of the individuals with ongoing support services that include:

Assessments - Job Development - Job Sampling - Job Coaching - Customized Employment - Long-Term Support

Supported Employment Major Services

Job Development - Assistance looking for work through application development, resume/cover letter development, interview preparation and contact with employers both with and on behalf of the participant.

Job Coaching - Assistance learning tasks and workplace adjustment. Counseling on inherent challenges of work and assistance developing communication between participant and employer.

Supported Employment - What it is not

Supported Employment is considered to be a vocational/educational service as defined by the funders who pay for it. 100% staff presence is not possible for the long term. It is <u>not</u> the only service that can be provided at a paid job. If you have these needs, a different service than Supported Employment may be appropriate.

- Community Based Supports Assist with interactions, task prompting
- Behavioral Supports Address behaviors in case they occur
- Personal Aide Services Safety monitoring, transitioning, medication

How to prepare

To get the most out of Supported Employment, there are things you can do to improve the chances of finding a great job that you love and be successful using the supports that are available. Supported Employment is designed to fade away, so moving towards independence is key!

By building a good foundation from which to start looking for work, you will have better luck finding and keeping a job you enjoy.

(Also, remember, your first job is rarely your last, everyone starts somewhere!)

Where to start? - Building the Foundation Before Looking For Work



The Foundation - What to do at **home**...

Who? - You. Participate in household activities independently - without prompt!

What? - Setting table, meal prep, trash, sweeping, laundry, dishes or mail, or any other skill

Where? - Anywhere, anytime! The key is developing independence

Why? - Independence skills, priority management, responsibility and following instructions

The Foundation - What to do in **community**...

Who? - Persons you know (or are known by) in the community

What? - Attending community events and/or volunteering

Where? - Recreation department, animal shelter, food bank, fire house, police station, first aid squad, businesses, seasonal activities, and the library

Why? - Build network, have relationships, become aware of resources, interact with community and develop choice making skills

The Foundation - **Community**, continued...

Who? - Teammates, coaches, instructors

What? - Sports, lessons, classes, gyms, outdoors

Where? - School, recreation departments, fitness centers, neighborhood

Why? - Teamwork, listening skills, communication, problem solving, decision making, goal setting, time management

Who can help? - State Agencies (Funders)

Vocational Services Only (Supported Employment)

- Division of Vocational Rehabilitation Services (DVRS)
- Commission for the Blind and Visually Impaired (CBVI)

Full Spectrum of Life Services (Including Supported Employment)

Division of Developmental Disabilities (DDD)

The Division of Vocational Rehabilitation Services (DVRS)



A state run agency that provides vocational services for individuals who qualify and possess, "...any physical or mental impairment that is a substantial impediment to employment..." Services are arranged/approved by a Vocational Rehabilitation Counselor. Services can include:

Vocational Counseling - Placement Services - On-the-job Training - Supported Employment - Community Based Work Evaluation - Job Seeking Skills - Job Accommodations - Skills Training - College Training - Physical/Emotional Restoration - Mobility Equipment - Driver Training - Vehicle/Home Modification

The Commission for the Blind and Visually Impaired (CBVI)

Technically a "sister" agency of the Division of Vocational Rehabilitation Services. Services are similar, but geared to serve individuals who live with visual impairments. Besides the services offered in the last slide, the Commission can provide:

Assistive Technology Support for school or work - Computer Training - Business Enterprise Programs - Joseph Kohn Training Center

The Division of Developmental Disabilities (DDD) State of New Jersey Department of Human Services Division of Developmental Disabilities

The **Division of Developmental Disabilities** provides public funding for services and supports that assist New Jersey adults with intellectual and developmental disabilities age 21 and older to live as independently as possible. Services and supports are available in the community from independent providers, and in five state-run developmental centers. Participants must qualify for Medicaid and meet **DDD**'s eligibility criteria.

*Before using **DDD** to pay for Supported Employment, you must reach out to **DVRS** see if you qualify first! **DVRS is the <u>primary</u> funder** for initial supports and **DDD is the <u>secondary</u> funder**.

Who Provides Services?

The actual Supported Employment service is provided by different agencies around the State and paid for by "**funders.**" The funder approves the agencies and the participant is able to choose which agency is best for them.

DVRS/CBVI - <u>Vocational Counselors</u> can approve services for the selected agency and authorize **Vouchers** for specific services

DDD - The <u>Support Coordinator</u> writes the participant selected agency into the **Service Plan** and defines the desired outcomes.

Supported Employment - Primary and Secondary Funders


Since both DVRS and DDD provide Supported Employment the agencies have an MOU that states:

The "primary" provider of Supported Employment services is the **Division of Vocational Rehabilitation Services.** In most cases, this agency funds the initial Supported Employment services such as looking for work and temporary increased support during the first days of hire at a new position.

The "secondary" provider is the **Division of Developmental Disabilities** (when applicable) and traditionally covers long term support.


*Not everyone who qualifies for DVRS qualifies for DDD (and vice versa) and some people qualify for both!

DVRS and/or **DDD** Who Funds Services?

The Arc of New Jersey is a Medicaid certified and CARF accredited provider of Supported Emp services that works with DVRS, CBVI and DDD to provide:

- Job Development
 - Application Assistance
 - Employment Seeking Skills Development
 - Contacting Local Businesses
 - Resume and Cover Letter Development

- Job Coaching
 - On the job training assistance
 - Development of "natural support"
 - Career coaching
 - Reasonable accommodations

SSI, Medicaid and other benefits...

If you are working, you will be able to earn significantly more income than an SSI check can provide!

New Jersey also has one of the **BEST** Medicaid "buy-in" programs in the country, WorkAbility. Through WorkAbility, Individuals can earn up to **\$60,000** annually and maintain less than **\$20,000** in assets (not including a primary residence or vehicle)

- 1. Complete online or paper referral
- 2. You will be contacted by local DVRS office and given instructions on application
- 3. Apply, and once case is opened...
- Ask your Vocational Rehabilitation Counselor about "Supported Employment"
- If approved, you may choose an agency and the authorization is sent

What if I am enrolled in DDD?

Even if you qualify for DDD, you must apply for DVRS services if you are interested in Supported Employment. Once you apply, one of 2 things can occur:

- Accepted/Receive SE Services
- 2. Denied/Given "F3 Form"

F3 Form

This form proves you attempted to get services from DVRS but were denied. If your DDD Support Coordinator uploads this form to the DDD system, you will be able to use your own DDD budget for Supported Employment Services.

You may choose an agency with your Support Coordinator

What about "Long Term" Supports?

Enrolled in DVRS Only

If you are only eligible for DVRS and not DDD, your Vocational Counselor can approve Long Term Follow-Along (LTFA)

So long as you maintain your current job you could receive **3 hours per month** of Job Coaching Supports from DVRS.

Enrolled in DDD Only or Both DDD/DVRS

If you are enrolled in DDD, your long term supports, once stable, are funded by your DDD budget. (You will leave DVRS if enrolled, exact monthly hours vary by needs/budget availability)

*If using DVRS for pre-placement/intensive services, It is advisable to choose an agency that is both DVRS and DDD approved to provide Supported Employment to ensure consistency.
