Final Budget Includes \$20 million for DSPs



After a prolonged back and forth between the Governor and the Legislature, a FY19 Budget was signed late last night and it includes a \$20 million line item for Direct Support Professionals. Although this funding is less than what we were advocating for, we are happy that the needs of people with intellectual and developmental disabilities remained a priority to our elected officials. The Arc Hosts Advocacy Summit on Sexual Abuse

For decades, The Arc of New Jersey has worked to enact policy to protect people with intellectual and developmental disabilities from sexual abuse, and to educate the public so that they become our partners in keeping people safe. We have also developed



programs for people with I/DD to educate and support them, and reduce their risk of being a victim. Recently, NPR published a series focusing on sexual abuse of people with I/DD and the rates of abuse that they reported are staggering. In our continued efforts to prevent further abuse from occurring, The Arc of New Jersey hosted a Leadership Summit to bring stakeholders together in order to brainstorm real solutions for addressing this important issue. The Summit to Address Sexual Offenses Against People with I/DD: Blueprint for an Empowered Future, took place on June 14th at the New Jersey Law Center and included remarks from

Leigh Ann Davis, Criminal Justice Initiatives Director from The Arc US, and James Meadours, self-advocate and social activist. The Arc of New Jersey will now work to author a blueprint for change that will identify ways to educate our community and prevent further victimization. NPR reporter Joe Shapiro, who authored the original series on this issue, attended our Summit and published the following: States Aim to Halt Sexual Abuse of People with Intellectual and Developmental Disabilities. The Arc of New Jersey is grateful to the New Jersey Council on Developmental Disabilities for contributing funds toward this important event.


The Arc of Essex Talks Preexisting Conditions with US Senator



The Arc of Essex County's Executive Director Linda Lucas and the Chapter's Board President Marnie McNany participated in a roundtable conversation about recent threats to the Affordable Care Act (ACA) with US Senator Bob Menendez in June. The event aimed to highlight the potentially harmful impacts of the Justice Department's recent court filing that announced the Department would no longer defend certain provisions of the ACA, including the provision that protects consumers with preexisting conditions. This could be harmful to some individuals with intellectual and developmental disabilities. The event was an opportunity to keep people with I/DD included in the conversation as these and other healthcare related decisions are made on the federal level. Marnie did an outstanding job sharing her story as a mom to Mary, her 16year-old daughter who has Down syndrome. NJ Launches ABLE Accounts to Help People Save

The New Jersey Department of Human Services announced the launch of the NJ ABLE program to help individuals with intellectual and developmental disabilities save for expenses without jeopardizing their eligibility for entitlement programs like Medicaid. FINDS Survey Sheds Light on the Caregiving Experience

In 2017, The Arc launched the Family & Individual Needs for Disability Supports (FINDS) survey, to assess the state of caregivers of individuals with



intellectual and developmental disabilities (I/DD) in the United States. The survey, conducted by The University of Minnesota's Institute on Community Integration in collaboration with The Arc, and resulting Community Report, shed light on the experiences of families who provide supports to a family
