Advocacy Focuses on FY21 Budget, Bills

The Legislature recently passed four pieces of legislation impacting people with intellectual and developmental disabilities (I/DD) that now await action by the Governor. These bills include:

- A4608/S3099 which provides for the regulation and licensing of applied behavior analysts
- S4139/A5751 which allocates \$250,000 to the Rutgers School of Dental Medicine to help address the shortage of special-needs dentists who serve patients with physical disabilities and behavioral challenges.
- A2705/S484 which revises the State's newborn screening program and establishes a Newborn Screening Advisory Review Committee which would be authorized to make recommendations on the disorders to be screened for by the Department of Health, as well as on screening technologies, treatment options, and educational and follow-up procedures, to be used in the State's newborn screening program.
- **S4141/A6011** which authorizes a parent or guardian to request the use of an individualized health care plan for a student with epilepsy or a seizure disorder.

In some situations, however, public schools are simply not able to do this. That is why the federal law requires your local school district to consider a full range of options – including private schools – when determining a child's placement.
