

Budget Advocacy Continues as Fiscal Year Winds Down

The Arc of New Jersey's Executive Director Tom Baffuto was honored to meet Assemblywoman Haider last month at a site visit hosted by The Arc of Bergen & Passaic Counties. The Assemblywoman got to tour the wonderful programs offered by the Chapter and to meet individuals who benefit from services, as well as the staff who support them. Also last month, The Arc of New Jersey continued to meet with members of the Senate and Assembly Budget Committees on our priority funding areas for the Fiscal Year 2023 Budget. These include maintaining appropriations proposed by the Governor for DSP wages and day program rate increases, among other things, and adding \$9.5 million to increase the amount of respite hours for children with IDD served through the Children's System of Care within the Department of Children and Families. Chapter Spotlight: The Arc of Hunterdon Says Goodbye to Long-Time Executive Director After Years of Service



Jeff Mattison, Executive Director at The Arc of Hunterdon, will retire from the organization at the end of the month after many years of service to people with intellectual and developmental disabilities and their families. Jeff is a committed advocate for those we represent and his work, in collaboration with his team, has advanced and expanded services and supports for those who rely on them in Hunterdon County. We take this opportunity to learn more about Jeff's journey as he prepares for the future.

1. How many years have you worked at The Arc of Hunterdon County and what originally attracted you to this line of work?

My time as Executive Director at The Arc of Hunterdon County began in 2007. I was introduced to The Arc in 1995 when my immediate next-door neighbor, (who just happened to be employed by The Arc's accounting firm), called me to say that a fellow by the name of Tom McKenna was looking to start a Business Advisory Council at an agency in Hunterdon County that

supported people with disabilities. The Council was designed to explore employment, transportation, and real estate opportunities for the agency's clients. After meeting with Tom and serving on the committee for just a short time, I was invited to join the Board of Directors in 1997 and served as Board President from 2005 through 2007. It was then that my predecessor retired and the position of Executive Director was offered to me by The Arc of Hunterdon Board. What really attracted me to the agency and its work, however, was an annual picnic event where I was introduced to the amazing individuals supported by The Arc. Planning for Adult Life Program Awarded Employment First Grant

The Arc of NJ was thrilled to be awarded a grant from the NJ Council on Developmental Disabilities to enhance its focus on competitive employment for high school students receiving special education services, once they leave school. The *Employment First Initiative* will be implemented by the Planning for Adult Life Program as an additional offering focusing on all the tools students with disabilities



will need as they leave school and enter the world of work. The *Initiative* will work intensively with 4 schools, conducting intensive hands on workshops with students and educating families. In addition, teachers from the schools will participate in "train the trainer" sessions so that they will be able to continue the program with future classes.

Healthcare Webinar Examines Needs of People with IDD Post-COVID

The Arc of New Jersey's Mainstreaming Medical Care Program hosted a four-part healthcare webinar series last month focused on the medical, behavioral and dental supports that people with intellectual and developmental disabilities will need as we transition out of the pandemic. Tell Congress: Support the SSI Savings Penalty Elimination Act NOW!

The <u>Supplemental Security Income</u> (SSI) program provides critical support for millions of people with disabilities and their families to be able to afford necessities like food and rent. But it

has many rules that make it hard for people to save money and get out of poverty. SSI has an asset limit that has not been updated since 1989. Assets include money in bank accounts, property, and savings. Right now, people who get SSI can only have \$2,000 in assets. Married couples can only have \$3,000. These asset limits mean that people cannot save money and force people with disabilities into poverty. TAKE ACTION: Urge your U.S Senators to support people with disabilities and their families by cosponsoring the bipartisan SSI Savings Penalty Elimination Act (S.4102) which would raise these asset limits.



Disability Rights New Jersey Survey Opportunity

Disability Rights New Jersey is the state's designated Protection and Advocacy agency under federal law. They advance the human, civil, and legal rights of persons with disabilities and promote their self-determination, independence, productivity, and integration into all facets of community life. To ensure that their limited resources are used to address the most pressing needs of people with disabilities across the state, they are seeking input from people with disabilities, family members, professionals, service providers, and the general public to guide in determining their priorities and areas of focus for the next three years.
